

ITyStudio | GDPR, Privacy Policy

I. PERSONAL DATA

In general, it is possible for you to visit the ITYSTUDIO site without providing any personal information about yourself. In any case, you are under no obligation to transmit this information to ITYSTUDIO.

However, in the event of a refusal, you may not be able to benefit from certain information or services you have requested. In this respect, ITYSTUDIO may in some cases ask you to provide your full name, e-mail address and telephone number (hereinafter your "Personal Information"). By providing this information, you expressly agree that it may be processed by ITYSTUDIO for the purposes indicated in point 2 below and for the purposes mentioned at the end of each form.

In accordance with the General Data Protection Regulation adopted by the European Parliament on 14 April 2016, and the amended Data Protection Act of 6 January 1978, ITYSTUDIO informs you of the following points:

1. Identity of the controller

2. Purposes of the processing operation

ITYSTUDIO may process your Personal Information:

(a) for the purpose of providing you with the information or services you have requested (in particular: sending you the Newsletter, commercial offer, white papers or assessing your level of compliance via a quiz)

(b) in order to be able to contact you about various ITYSTUDIO-related events, including product updates and customer support.

3. Receivers

Only ITYSTUDIO is the recipient of your Personal Information. These, whether in individual or aggregate form, are never passed on to a third party, notwithstanding the subcontractors ITYSTUDIO uses (more information about them can be found in point 7 below). Neither ITYSTUDIO nor any of its subcontractors market the personal data of visitors and Users of its Site.

4. Shelf life

Your Personal Information is kept by ITYSTUDIO only for the time corresponding to the purpose of the collection as indicated in 2 above, which may not in any case exceed 36 months.

5. Computer Rights and Freedoms

You have the following rights regarding your Personal Information, which you can exercise by writing to us at the postal address mentioned in point 1 or by completing the form on the right.

Right of access and communication of data

You have the right to access Personal Information about yourself.

However, due to ITYSTUDIO's obligation of security and confidentiality in the processing of personal data, you are informed that your request will be processed subject to proof of your identity, in particular by producing a scan of your valid identity document (in the case of a request via our dedicated electronic form) or a signed photocopy of your valid identity document (in the case of a written request).

ITYSTUDIO informs you that it will be entitled, where applicable, to object to manifestly abusive requests (in terms of their number, repetitive or systematic nature).

Right to rectify data

Under this right, the legislation empowers you to request the rectification, updating, blocking or deletion of data concerning you which may prove to be inaccurate, erroneous, incomplete or obsolete.

In addition, you can define general and specific guidelines regarding the fate of personal data after your death. If necessary, the heirs of a deceased person may request that the death of their loved one be taken into consideration and/or that the necessary updates be made. Right of opposition

The exercise of this right is only possible in one of the following two situations:

When the exercise of this right is intended to prevent the data collected from being used for commercial prospecting purposes.

6. Response times

ITYSTUDIO undertakes to respond to your request for access, rectification or opposition or any other additional request for information within a reasonable period of time, which may not exceed 1 month from the receipt of your request.

7. Authorized service providers and transfer to a third country of the European Union

ITYSTUDIO informs you that it uses its authorized service providers to facilitate the collection and processing of the data you have provided us. These service providers may be located outside the European Union. Our European and international service providers are committed to compliance with the GDPR regulations.

8. Complaint to the competent authority

If you consider that ITYSTUDIO is not fulfilling its obligations with regard to your Personal Information, you may file a complaint or request with the competent authority. Your APD (National Data Protection Authority) will receive your complaint and will investigate to determine the appropriate measures to take in the next step. If supervision is implemented, you will be notified within three months. If you do not receive notification, you may apply to a court to request a response.

In accordance with the GDPR, your request will be processed within 30 days of the date on which we receive all the information required to process your request. If your request is complex, this period can be extended to a maximum of two months, but we will inform you in advance.
